IMAGINE CHILDREN'S MUSEUM IS A 45,000 SQUARE FOOT FACILITY IN EVERETT, WA THAT SERVES CHILDREN AGES 1-12 YEARS AND THEIR CAREGIVERS. IMAGINE PRIMARILY SERVES FAMILIES IN SNOHOMISH COUNTY AND THE GREATER PUGET SOUND REGION, BUT EACH YEAR THE MUSEUM DRAWS VISITORS FROM ALL OVER THE U.S. AND THE WORLD. SINCE OPENING IN THE CURRENT LOCATION IN 2004, EXHIBITS, PROGRAMS AND ACTIVITIES HAVE SERVED NEARLY THREE MILLION PEOPLE, MORE THAN 252,000 IN 2018 ALONE.
